OPEN SESSION

The meeting was called to order at 11:30 a.m. by Chairman Lawrence D. McHugh. Trustees Richard T. Carbray, Jr., Marilda L. Gandara, and Thomas D. Ritter were in attendance.

Trustee Reviczky was on the call, but was unable to cast a vote.
