MINUTES OF THE MEETING
OF THE
BOARD OF TRUSTEES
OF

THE UNIVERSITY OF CONNECTICUT
Held at the Marine Research Laboratory
in Noank, July 20, 1966

The meeting was called to order at 10:25 a. m. by Chairman John J. Budds. Those present were: Governor John Dempsey; Mrs. Bailey; and Messrs. Benton, Bishop, Budds, Donahue, Driscoll, Gill, Holt, McCormick, Nielsen, and Sanders.

Also present were: President Babbidge; Mr. Gant, Provost and Academic Vice President; Mr. Evans, Vice President for Financial Affairs; Commissioner Conkling; Mr. Clark, Associate Dean of the Graduate School; and Mr. Rankin, Director of the Marine Research Laboratory.

All actions taken at the meeting were by unanimous vote of those present.

1. The minutes of the meeting of June 15, 1966 were approved.

3. Governor Dempsey commented on the splendid progress that the University is making and expressed his appreciation to the Board

and President Babbidge for their outstanding service.

4. Mr. Gant reported that 14,400 applications for admission in September, 1966 have been received. Of these, nearly 2,100 have been enrolled as freshmen at Storrs. This represents an increase of about one hundred completed freshmen admissions over comparable figures for July, 1965. The total number of undergraduates on the Storrs campus will be some six hundred more than in September, 1965. However, the number of new students in all categories for both Storrs and the branches, including freshmen and transfers, is expected to be about one hundred less than in 1965. Mr. Gant pointed out that the number of dismissals at the end of the 1966 Spring semester dropped sharply and the resulting increase in the number of continuing students has placed a limitation on the number of new students that can be accommodated at Storrs. Mr. Gant also reported briefly on the qualifications of the 1965 entering freshmen and the lower attrition for the freshman class.

7. A report on a proposed program in marine sciences proposed by a special faculty committee consisting of Messrs. Clark, Coogan, and Rankin was presented by Associate Dean Clark. Dean Clark explained the nature of the proposed program and the relationship of the program to existing programs in marine biology, engineering, the natural sciences, and several other fields in the University. Copies of the committee's report were distributed to Board members along with professional summaries for members of the faculty who have interests in the marine sciences. The Board expressed a strong interest in the program and thanked Dean Clark and the other members of the committee for the report. The Board also VOTED to authorize the establishment of an Institute of Marine Sciences and to authorize the development of budget requests which would be required to implement the program.

The development program is directed toward the evolution of a practical unit for use in the University of Connecticut dental facility, the design of which is to be based on known present needs and on future flexibility to meet changing needs.

This proposal follows a preliminary effort by the developers which has resulted in a promising new dental equipment design concept. Inherent in this design are functional and structural characteristics hitherto never applied to equipment used in the practice of dentistry.

- (I) President Babbidge and Mr. Gant commented on the situation with respect to housing for students in September, 1966. Construction on three new dormitories holding a total of 630 students is virtually at a standstill because of a strike of masons. Since students have been admitted with the expectation that the dormitories will be completed by September, it appears that the University will be facing a serious shortage of permanent housing at the beginning of the year. Currently, steps are being taken to provide temporary housing until the dormitories are completed.
- (J) President Babbidge advised the Board that it has been necessary to take over the Continuing Education Center for student housing in the fall and that housing for persons attending conferences will not be available on campus during the academic year. The Board agreed to take up the matter of facilities for continuing education at its September meeting.
- (K) Mr. Evans distributed copies of a budget document covering current operations for the fiscal year ending June 30, 1967.
- (L) Mr. Holt reported on discussions of the Commission on Higher Education relating to provisions for an increased number of students at the University of Connecticut. The Commission had also discussed the utilization of branch facilities and a limitation on the establishment of additional branches.
- (M) THE BOARD VOTED to approve the establishment of the
